




Equipment Maintenance

- Regularly scheduled maintenance
- Inspection/replacement of consumable pieces, gaskets, seals, bearings



Raw Materials

- Inspect the packaging, is it damaged?
- Does the label match the order?
- Is there testing involved? Store in Quarantine?
- Sampling Procedures...trust but verify.



Work-in-Process

- Batch tickets created which track lot# and amounts used, specify specifics if different than standard run.
- Samples of each batch are taken according to sampling protocol
- Samples are analyzed in house or shipped to third party and results are compared against the product specifications
- Quality control results are entered into our ERP system, linked with batch#
- Lot Status is changed from QC Hold to ALL, allowing material to move to next step in processing.



Equipment used in Work-in-Process

- Proper design and development is critical.
- Adherence to maintenance protocols supports consistency and safety.
- Regular calibration supports consistency and high quality
- Procedures and recipes designed to meet specifications consistently.
- Performance evaluations and monitoring support high quality



Finished Goods

- Samples of each batch are taken according to sampling protocol
- Samples are analyzed and results are compared against the product specifications
- Quality control results are entered into our ERP system, linked with batch#
- Lot Status is changed from QC Hold to ALL, allowing material to be delivered into a sales order in our ERP.
